200 Club Rules

1. The purpose of the 200 Club is to raise funds for Coventry Carers' Centre, registered charity number 1074758.
2. The name of the draw is the 200 Club regardless of the number of shares.
3. The 200 Club will be administered by a Promoter appointed by the Management Board of Centre.
4. 50% of the total annual subscriptions will be paid out in the form of prizes.
5. Prizes will be set on a pro rata basis of the actual numbers of participants at the time of each draw. The draws shall run from 1st December 2011 onwards for a period of 12 months or until renewal of the next 12 month subscription by the share holder.
6. Membership for the 200 Club will be open to anybody aged 16 or over.
7. A purchaser of a share becomes a member of the Club.
8. Participants are entitled to hold any number of shares.
9. The number of shares in the 200 Club shall be unlimited and each share shall be allocated a unique number of which members will be informed.
10. All shares purchased in a calendar month will be included in the next month's draw, which will take place on the 1st working day of each calendar the month.
11. The subscription for each share is £24 per annum.
12. All participants must pay annually **in advance** by cheque, Standing Order or electronic transfer.
13. The winning numbers will be selected by a web based random number generator in the presence of at least 2 members of the Carers' Centre staff.
14. The results will be posted on our website www.coventrycarers.org.uk and displayed at the Carers' Centre.
15. The winners' cheques will be sent out to the last known address held by the Centre. It is the responsibility of the member to advise us of any change of address. Any prize cheque not cashed within 6 months will be deemed a donation to the Centre.
16. The Centre will not pay a prize to any participant other than the purchaser of a winning share or name of the gift holder on the membership form.
17. No member will be included in the draw if the annual subscription has not been received. It is the responsibility of each member to make sure they have paid their subscription. The Centre reserves the right to reallocate any number where payment has not been received.
18. Any decision by the Centre to end the 200 Club will be by one month's notice to all members.
19. Under no circumstances can subscriptions be refunded.

20. The Centre Manager will, in the first instance determine any dispute. An appeal may be made to the Carers' Centre Management Board, whose decision shall be final.
21. The Lottery is intended to be a private lottery under the provisions of the Gambling Act 2005 Section 14.
